Citi named Best Bank for Financing in Asia by Euromoney

Hong Kong, 30 August 2021 – Citi was named Best Bank for Financing in Asia by Euromoney in their recent annual awards. The editorial award recognizes a bank’s regional strength in debt and equity capital markets, lending (including structured and leveraged), M&A financing, risk management trades for all client sectors. In the last 12 months, Citi has raised over US\$100bn for regional clients and is currently ranked the top IPO bank in Asia, according to league table data – of which nearly 1/3rd was sustainable financing related.

“We are running at record levels for capital raising for clients – with over US\$100bn raised year to date. This is a mix of balance sheet strengthening and also opportunistic financing to support growth,” said **Jan Metzger, Citi’s Asia Pacific Head of Banking, Capital Markets and Advisory**.

Metzger pointed to the bank’s strong global and regional network as a key factor in the award win.

“There is massive transformation happening across all industries and with a global network this has helped sharpen our dialogue with clients as they increasingly want a global perspective. Our network-driven strategy allows us to help clients grow in any country where they do business. This includes multinationals who are expanding globally, particularly in emerging markets, and emerging markets companies that are growing beyond their home market and region.”

He was also upbeat about the future ahead.

“2021 is the year Asian clients really embraced capital markets. Tech has dominated and it has been across the region - Indian ECM issuance is running at levels of the last three years combined, you have had landmark IPOs across India, Korea, Philippines and Indonesia for example, and I think we are just getting started really, the pipeline is the longest and strongest it has ever been across the region.”
