

Terms and Conditions Citi Miles Bonus Program:

General Condition:

- a. This program is valid only for Citi PremierMiles Primary Card.
- b. Program period is 15 September 2021 – 31 March 2022.
- c. 500 bonus Citi Miles is valid with a minimum accumulated transaction of Rp10.000.000,- per month for domestic and overseas transaction with foreign currencies in the specified merchant categories. No applies multiply.
- d. Merchant categories: Supermarket, Insurance, Transportation, 1Bill (monthly routine bill payment), Entertainment (including fitness membership), Travel, Hotel, Airlines.
- e. Citi PremierMiles Supplementary Card's transactions in the specified merchant categories will be counted into the primary card's accumulative transaction in achieving Citi Miles bonus.
- f. Calculation for 1 (one) month transaction is from card billing statement date to the card billing statement date of the following month.
Example: Card billing statement date is the 5th, so the accumulated transactions that are counted are from the 5th to 4th of the following month
- g. Transactions that are calculated for Citi Miles bonus are transaction that have been posted in the Citibank system.
- h. Electricity and water bill payment transactions, EazyPay transactions in the specified merchant category, transactions at specified merchants and converted to EazyPay by phone, website, or microsite are counted to get Citi Miles bonus but do not get regular Citi Miles.
- i. Bonus Citi Miles will be credited to Citi PremierMiles Basic Card on the billing statement date.
- j. Citi Miles reversal will be applied in the statement cycle when transaction causing the rewards reversal is posted.
- k. Accelerated/bonus Citi Miles will be awarded only if cumulative value of new purchase transactions in the respective spend category is higher than the value of transactions reversed.
- l. For transactions in foreign currencies, the calculated transaction value is the transaction value in Rupiah which is billed in the Billing Statement using the exchange rate from Visa / Mastercard on the transaction posting date.
